INTRODUCTION

The Doctor of Philosophy is designed so that graduates will have undertaken a program of research training and independent supervised study resulting in significant and original research outcomes and culminating in a thesis or equivalent for independent examination by three external examiners of international standing. The program may include advanced coursework designed to develop the student's research skills and capacity to make a significant contribution to original knowledge.

SUPERVISION

Each candidate is required to have a minimum of two supervisors who will provide support and academic guidance throughout the degree. The candidate's supervisors will assist the candidate with the preparation of their research proposal. The supervisors will also mentor and direct the candidate throughout the research phase and up to the point the thesis is put forward for examination.

Before submitting an application, prospective students are encouraged to contact the relevant School or the University's Research Office to arrange a discussion with a suitably qualified member of academic staff.

PROGRAM STRUCTURE

The Doctor of Philosophy is a thesis-based research degree, normally comprised exclusively of supervised research, but which can include research training coursework if appropriate.

MODE OF STUDY AND ASSESSMENT

Candidates in the PhD program can undertake their research in either a full-time or a part-time capacity. The standard time for completion of the Doctor of Philosophy (not including periods of approved leave of absence) will normally be three years for a full-time student and six years for a part-time student. The minimum time for completion will normally be two years. The PhD thesis is assessed by external examiners.

ADMISSION REQUIREMENTS

The following criteria are required for a student to be admitted to the PhD program:

- Completion of a research Master's degree (by Research or Coursework and Thesis), appropriate to the professional field of the applicant (or equivalent) at a high level of achievement; or
- A Bachelor's degree with Honours (Class 1 or Class 2A Honours level or equivalent); or
- In exceptional circumstances, an equivalent academic or professional background that is considered by the Dean of the School to be an appropriate preparation for independent study and research at a doctoral level.

An applicant may be required to demonstrate an ability to understand and communicate in both written and spoken English at a level adequate for the purpose of pursuing the program of study as deemed appropriate by the Dean of the School.

FEES AND SCHOLARSHIPS

Domestic Students

In accordance with the *Commonwealth Scholarships Guidelines (Research) 2017*, domestic research students are eligible to have Higher Degree by Research (HDR) fees paid for by the Commonwealth Government through a Research Training Program (RTP) Fees Offset Scholarship.

Domestic students can also apply for stipend scholarships. These scholarships are very competitive and are awarded to students of exceptional research potential. The scholarships are for the purpose of assisting with general living costs for the duration of the research degree.

International Students

All international research students are required to pay full fees for the length of their research degree. Please refer to the International Guide for current program fees.

The University is also keen to support high calibre international students. International students are also eligible to apply for Commonwealth Government Research Training Program (RTP) Scholarships (Fees Offset and/or Stipend) and the University
