3 PURPOSE

These Program Requirements set out the approved requirements for the Professional Certificate in Wellbeing in Education.

4 OVERVIEW

4.1 Campus Availability

The Professional Certificate in Wellbeing in Education has been approved for delivery on the Fremantle Campus and the Sydney Campus.

4.2 Student Availability

The Professional Certificate in Wellbeing in Education is available for enrolment to domestic Students.

4.3 Australian Qualifications Framework

The Professional Certificate in Wellbeing in Education is non AQF qualification.

4.4 Duration

The Volume of Learning for the Professional Certificate in Wellbeing in Education is 0.25 years of equivalent full-time study.

The Program is only available Part-time.

4.5 Maximum Duration

The maximum period of time within which a student is permitted to complete the Professional Certificate in Wellbeing in Education Award is 2.5 years (including any periods of approved leave of absence) from the date on which they were first enrolled into the program by the University.

4.6 Study Mode

The Professional Certificate in Wellbeing in Education is offered in External/Online mode.

4.7 Professional Accreditation

There are no professional accreditation requirements applicable to this Program.

5 ENTRY REQUIREMENTS

5.1 University Admission Requirements

6.1 There are no practicum or internship requirements for the Professional Certificate in Wellbeing in Education.

7 PROGRAM REQUIREMENTS

7.1 Program Description

The Professional Certificate in Wellbeing in Education is designed as a nested program within the Graduate Certificate in Wellbeing in Education. Students may articulate from the Professional Certificate to the Graduate Certificate upon successful completion of two courses. The addition of this nested pathway will further support educators and educational leaders to develop advanced knowledge of wellbeing in education to enable the development of process and practice leading to a positive impact on school culture and student outcomes. Participants will engage with contemporary approaches to wellbeing, exploring theory and research to build an evidence base of best practice. High level understandings of key concepts including wellbeing, resilience and pastoral care will be developed with a particular focus on the implementation of processes and practices that support wellbeing, resilience and pastoral care for both staff and students. This program challenges participants to demonstrate highly developed cognitive, technical and creative skills, critique research and practice, generate understanding of complex educational and psychological issues in wellbeing, and to integrate knowledge with their own practice as educators and school leaders.

7.2 Program Learning Outcomes

Upon successful completion of the Professional Certificate in Wellbeing in Education graduates will be able to:

1. Apply advanced theoretical knowledge, skills and professional practice to support and lead wellbeing in educational contexts
2. Critically evaluate theory, research and professional practice to generate approaches to cultivating wellbeing that reflect contemporary developments in the field.
3. Synthesise knowledge to identify and develop solutions to complex problems affecting staff and student wellbeing.
4. Apply highly developed cognitive, technical and creative skills with initiative, a high level of personal autonomy and accountability to generate understanding of complex educational issues in wellbeing.
5. Use communication and technical skills to implement, justify, and respond to critical issues impacting wellbeing in educational contexts.

7.3 Required Courses

To be eligible for the award of Professional Certificate in Wellbeing in Education students must complete a minimum of 50 Units of Credit chosen from the courses listed in Appendix A.

7.4 Elective Courses

There are no elective courses in the Professional Certificate in Wellbeing in Education.

7.5 Course substitutions

Course substitutions, where permitted, must be approved by the Dean.
