The third annual Tertiary Education Quality and Standards Agency (TEQSA) Conference and Higher Education Quality Forum (HEQF) in late November in Melbourne brought the higher education sector together around the theme: *Innovation, Excellence, Diversity*.

Keynote speakers and panel discussions over the first two days probed the theme offering delegates a range of views, penetrating insights and the opportunity to reflect on the current state of the sector. The final day featured more than 50 concurrent sessions.
