3 PURPOSE

These Program Requirements set out the approved requirements for the Master of Physiotherapy.

4 OVERVIEW

4.1 Campus Availability

The Master of Physiotherapy has been approved for delivery on the Fremantle Campus.

4.2 Student Availability

The Master of Physiotherapy is available for enrolment to domestic Students and international students with a student visa.

4.3 Australian Qualifications Framework

The Master of Physiotherapy is accredited by the University as a Level 9 AQF qualification.

4.4 Duration

The Volume of Learning for the Master of Physiotherapy is three (3) years of equivalent full-time study. A student is not able to enrol on a part time basis. This program is delivered in an accelerated mode over two (2) years.

4.5 Maximum Duration

The maximum period of time within which a student is permitted to complete the Master of Physiotherapy Award is 4 years (including any periods of approved leave of absence) from the date on which they were first enrolled into the program by the University.

4.6 Study Mode

The Master of Physiotherapy is offered in Internal Study mode only.

4.7 Professional Accreditation

The Master of Physiotherapy is accredited by the Australian Physiotherapy Council.

5 ENTRY REQUIREMENTS

5.1 University Admission Requirements

To be eligible for admission to The University of Notre Dame Australia, all applicants must meet the <u>University's minimum requirements for admission</u>. The requirements for admission are detailed in the University's Policy: *Admissions*.

5.2 Specific Program Requirements for Admission

To be eligible for admission to the Master of Physiotherapy applicants must also meet the following specific requirements.

Pre-requisites and/or assumed knowledge Completion of:

5.2.1 A Bachelor of Exercise and Sports Science* with a minimum GPA of 2.5;

OR

A Bachelor of Science* with a major or specialisation in Exercise and Sports Science, with a minimum GPA of 2.5;

OR

Any Bachelor degree* with a minimum GPA of 2.5, AND which includes assessed studies in the following specific areas:

- Human Anatomy and Physiology;
- Human Pathophysiology;

*Including two semesters of human anatomy and one semester of pathophysiology covering the following indicative study areas: see PHTY1005, PHTY1006 and PHTY1007

- 5.2.2 Any inherent requirements or components (such as evidence of performance capability in a particular field of study) that need to be met to ensure that the academic requirements and integrity of a Program or Course are maintained.
- 5.2.3 An alternative pathway for Aboriginal and Torres Strait Islander applicants is applicable for this award.

6 PRACTICUM OR INTERNSHIP REQUIREMENTS

- **6.1** Students are to complete a variety of formal practicum experiences within the clinical setting as a part of this Program commencing in Year 1 of the Program. Clinical Placements operate in accordance with the Health and Universities Agreement for Allied Health Student Clinical Placements (2005) and Schedules to that agreement or its substitute in place at the time. The following courses are specific to clinical placement experiences:
 - PHTY5011 Clinical Education I and Practitioner Preparation
 - PHTY6011 Clinical Education II
 - PHTY6012 Clinical Education III, Practitioner Development, and Professional Issues
 - PHTY6015 Complex Issues in Physiotherapy Practice II and Clinical Education IV

7 PROGRAM REQUIREMENTS

7.1 Program Description

The Master of Physiotherapy is a 2-year full-time graduate-entry program that prepares graduates to become effective, culturally appropriate practitioners with a focus on the physiotherapist-client relationship as part of collaborative multi-disciplinary practice. This program includes a suite of physiotherapy-specific courses and clinical placement experiences to develop specialised knowledge and skills, enabling graduates to analyse critically, reflect on and synthesise complex information, problems, concepts, and theories. There is an advanced and integrated focus on ethical and professional communication and behaviours. Graduates of this program will have expertise in evidence-based and reflective practice fostering autonomous, adaptable physiotherapists well prepared to meet the challenges of current and future health provision across diverse practice settings. Graduates from this program will be eligible for registration as a physiotherapist with the Australian Health Practitioner Registration Agency (AHPRA).

7.2 Program Learning Outcomes

Upon successful completion of the Master of Physiotherapy graduates will be able to:

- 1. Apply advanced verbal and written communication skills with clients, families, carers, and service providers
- 2. Practice professional and ethical behaviour, demonstrating respect and sensitivity to clients with diverse social, cultural, and spiritual beliefs
- 3. Autonomously apply critical reflection and expert judgement to identify limitations in knowledge, skills, and abilities in order to plan and implement lifelong learning strategies
- 4. Synthesise complex information when accessing, and integrating best available evidence into physiotherapy practice
- 5. Apply advanced and integrated knowledge and skills to practice safe, effective entry-level physiotherapy across a range of settings
- 6. Employ critical analysis and expert judgement to formulate and conduct effective, efficient, and adaptable physiotherapy practice

- 7. Develop and communicate physiotherapy-based health promotion and collaborative management strategies to empower clients to participate in healthcare decisions and behaviours
- 8. Contribute to healthcare delivery through culturally safe, effective inter-professional communication, advocacy, and practice

7.3 Required Courses

To be eligible for the award of Master of Physiotherapy students must complete a minimum of 600 Units of Credit chosen from the courses listed in Appendix A comprising:

25 Units of Credit from one (1) Core Curriculum Course

575 Units of Credit from twenty-one (21) Compulsory Courses

7.4 Elective Courses

There are no elective courses in the Master of Physiotherapy.

7.5 Honours

Honours is not available within the Master of Physiotherapy Program.

7.6 Course substitutions

There are no approved course substitutions permitted in this Award.
